Formal Appeal

RE: Public Hearing Case PZA #2019-21 Request for Special Exception permission to operate a cold weather shelter at 205 N. Pine Street, Bunnell, Florida

As operators of Flagler County's only cold weather shelter, we are writing to appeal Decision PZA#2019-21 from the Planning, Zoning, and Appeals Board. This decision is appealed under Section 2-86 of the City of Bunnell Land Development Code. We are respectfully requesting a reversal of this decision. The initial application was for a special exception for a cold weather shelter offering a safe and humane refuge from extreme weather. This is consistent with the public interest of the City of Bunnell and Flagler County.

The Cold Weather Shelter, operated by Flagler County Family Assistance Center, known as The Sheltering Tree, opened in direct response to critical community need. Persons who utilize the shelter include victims of domestic violence, individuals in temporary financial crisis, families living in cars, the chronically or temporary homeless, and the working poor. The shelter does not create or contribute to homelessness in Bunnell, either directly or indirectly.

For eleven years, the cold weather shelter has worked with public and private stake-holders to address, coordinate, and support community concerns. The Flagler County Family Assistance Center has no paid members or workers. The Center receives no government funds, national or local, and is exclusively funded by donations from Flagler County residents and businesses.

The volunteers who run the shelter do not want to see Bunnell and the county lose this invaluable community asset providing a warm and safe place for the poorest and most vulnerable people in our community who do not have a voice.

We respectfully ask the commission to reverse the decision.





FL – 504 Continuum of Care Point in Time Count Total: 875




Flagler County Point in Time Count Total: 130



Flagler County by City Breakdown


Volusia County Point in Time Count Total: 745
